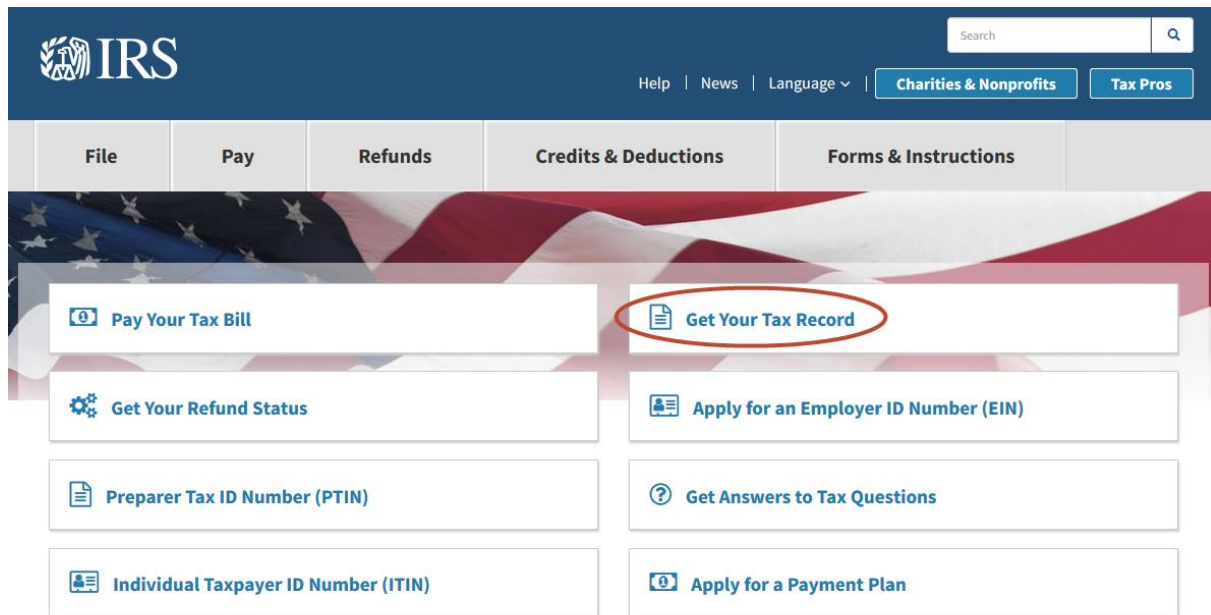
IRS TAX RETURN TRANSCRIPT REQUEST PROCESS

TAX FILERS CAN REQUEST A TAX RETURN TRANSCRIPT FROM THE IRS, FREE OF CHARGE, IN ONE OF TWO WAYS ON THE IRS WEBSITE WWW.IRS.GOV:
